Dear Friends of the FISH,

With Thanksgiving quickly approaching and dinner plans in the works, it is tradition for us to reflect on all that we are thankful for. Since the end of October, I have found myself being thankful for things that I have taken for granted my entire life. Things that have always been a part of my life, so I have never had to know what it is like to do without. Things such as not having to be put in adult situations as a young child, things such as not having transportation or the money to pay for public transportation, or choosing which bill needs to be paid first, and which can wait. Of course the list goes on and on. I have been doing an awful lot of reflecting since the end of October, because that is when I had the privilege to participate in the Community Action Poverty Simulation (CAPS), hosted by Southern Oregon Goodwill Industries.

You see, the people at the Southern Oregon Goodwill Industries know that maybe it isn't enough to work with people who struggle, or volunteer to assist those who need it the most. Don't get me wrong, it is some of the most important work and volunteers are a vital part of the success needed for many non-profit agencies, including here at The FISH. But what if you could spend a few hours in their shoes? CAPS does just that! It allows us as community members and leaders to be in a simulation, experiencing what it is like for in the life of the people in our community who are struggling.

Many of us were placed into family groups, where we played the role of a member in that family, while others played the roles of community members, such as pawnshop workers, grocery store clerks, daycare providers, teachers, and more. Trust me, it was very realistic! When the whistle blew, we had to go to school, work, etc. We had to figure out how to get from point A to point B. We had to pay bills, pay utilities, buy groceries, and sell our stuff just to keep afloat. And in between it all, life would happen! We would be handed cards that would throw a wrench into the middle of things just when we thought we were getting it all down. Cards like getting thrown in jail, or getting sick. And the kicker to the whole day was finding out that not a single scenario that ANY of us was given had any of us living below the poverty line! To think that anyone could make it on these very real life scenarios, with the situations, and income (or lack thereof), is beyond me.

It took me a few days before it really all sank in. In fact, it wasn't until after someone saw me in a news interview talking about the struggles of transportation during the simulation. They confirmed to me that transportation really is the problem. They started talking about the struggles of not being able to get a job without having transportation, but not being able to get transportation without a job. I am certainly thankful for my blessings now, far more than I ever had been before. And I am thankful for each and every one of you too! Without you, the FISH of Roseburg would not be able to help our friends and neighbors in their time of need. Have a safe and Happy Thanksgiving!
